## Introduction

This document is a summary of my research on a Harriman family. My great-grandmother, the maternal grandmother of my father, was a Harriman. Almost no information on these Harrimans was available to me from family sources. Over the past several years I have been collecting information about this Harriman family when and where I could. I regard my work on this family as highly incomplete. There are, as will be evident, many loose ends, some of which could be tied

together with further research. By putting together a summary of what I know up to this point, I hope to provide other researchers with an accessible synopsis of the work done and to stimulate the exchange of information on this family.

For me the name Harriman, until recently, has always been a family without a face. Even my father, who was born in 1890 (and died in 1989), had no personal contact over his long life with any relative named Harriman, despite that fact that, as I was later to discover, he had dozens of first and second Harriman cousins. On the next few pages I will work in a reverse chronological order, in rough correspondence to the progress of my research, and outline what is known about this family.

## Ruckles in Nebraska

John W. Ruckle was the maternal grandfather of my own father, Omer Kem Luther. ${ }^{1}$ When Dad was only two, in 1892, his mother, Ella Ruckle, Ella's only sister Ida Ruckle, and her father John W. Ruckle all died. We have a large painted tintype of Ella, a small tintype of Ida, and a Civil War tintype of John, which has been mounted in a frame and displayed in our home for many years.

These tintypes were for my father, and through him for me, almost the only connection with a Ruckle heritage. John W. Ruckle had brought Ella and Ida to Custer County, Nebraska, about 1888. They homesteaded west of Mason City, in Algernon Township. Nothing is known of the circumstances under which Ella met Arthur, my Dad's father. At the Custer County Courthouse is the marriage certificate of Arthur and Ella. It says that they were married on 9 June 1890, when Arthur was only 21 and Ella, I suspect, was only 14 years old. Arthur and Ella, it would turn out, were to have just two short years together. My dad, Omer, was born on November 12 of the first year of their marriage. Omer was joined in 1892 by a brother, Earsey, but he lived only eight months. Ella died on September 8 of the same year. Her father John had died earlier in the spring. Ida is said to have died that year as well, so in a mere six months the entire family, except the baby Omer and a child of Ida, were carried off. See the picture of Arthur, Ella and Omer in Appendix D.

## Harrimans in Iowa

It is through this Ruckle connection, already weakened by these early deaths, that my father is related to the Harrimans. The story which Dad knew, which I suspect came from John Ruckle via Arthur Luther, was that John Ruckle was the foreman on the Harriman farm in Kellerton, Iowa, and married the boss's daughter against the wishes of her father. When John's wife died, the Harrimans made it clear to John that he and the two girls were no longer welcome, so John picked up and moved on to Nebraska. Ruckle came in a wagon train with a number of other Ringgold County,

Iowa, natives, to the unsettled lands of Custer County. Whether there is any truth in the boss's daughter story is unknown. It could have been the embellishment of a simpler explanation. But the essential details of Ruckle's inferior economic situation in comparison to his Harriman inlaws, and the move to Nebraska, I have been able to confirm.

I used the Kellerton, Iowa, location, which was handed down in my family, and the fact that Ruckle was a member of a Minnesota regiment in the Civil War, to find the Harriman and Ruckle families in a variety of documents in both Iowa and Minnesota.

The Harrimans and Ruckles appear together in the 1880 Federal Census in Iowa. John Ruckle is listed in Athens Township as a 45-year old farmer, and Irena is his 31-year old wife. Ida is 12, and Ella is 4. In October of this year, according to the Ringgold County land records, Ruckle bought an 80-acre piece of land in Athens Township.

Ruckle's wife Irena is the daughter of a Harriman living in the same Township. Ruckle's land was a quarter-mile east of a farm in Section 6 of Athens Township which was owned by George Harriman. Harriman had purchased it in 1875, probably at the time of his move from Minnesota. It is likely that John W. Ruckle and his wife, Irena Harriman, came from Minnesota with the Harrimans. Since the Ruckles did not purchase their own farm for another five years, it is conceivable that they lived on the Harriman property and that John W. Ruckle worked for his father-in-law.

The farm of George Harriman is also in Athens Township, near the town of Kellerton. On the 1880 census Harriman is 51 , and a farmer. He has living at home with him his son George ${ }^{2}$ (age 16) and daughter Maggie (age 13). The elder George says that he was born in Ohio, but that his parents, both father and mother, were born in Pennsylvania. In all other places, however, George Harriman lists his birthplace as Pennsylvania. George's wife is listed as "Ellen," age 31, born in Indiana, whose parents were born in Kentucky. ${ }^{3}$ This, as we will note when we get to the Minnesota phase of the story, is a later wife of George Harriman, not the mother of his children.

In 1881 George Harriman sold the property in Section 6 of Athens Township. He bought land a mile to the southeast, in Section 9 of Athens Township, in 1882. This land was later sold to his children and remained in the family until 1910.

In February 1881 a David Louis Ruckle, age 32, son of Daniel Ruckle, was married to George's daughter Mary Ellen in Kellerton. It is not clear at this point what Daniel's relationship was to John W. Ruckle, but it seems probable that he was a brother. ${ }^{4}$ If so, then the two Ruckle brother married two daughters of George Harriman.

The state census in Iowa in 1885 enumerates both the Harrimans and Ruckles. They are living on farms on Range 28, Township 69, in sections $17^{5}$ and 5, respectively. This census preserves informal names. It calls John's wife "Rena." George Harriman's family consists of himself at age 56, born in Pennsylvania, Lindi E., age 33, born in Indiana, Ben Harriman, age 23, George W., age 20, and Magey, age 18. They are all listed as farming (if males) or keeping house.

In 1886 Ruckle's land was bought by a local lawyer who specialized in buying land for taxes at sheriff's sales. I would assume that Ruckle had been forced to give up his land for debts. By the end of the next year Ruckle brought his two girls, without their mother, to Nebraska, so Irena's death must be placed in the 1885-87 period. She died, therefore, about age 37 or 38 .

The Harrimans continued to live on in Ringgold County. George died on 16 February 1912. His son George W. Harriman, who took over the farm, died in 1957. His son Ben, who became widely known in the area, and worked for the Iowa legislature, died in 1951. All three are buried in Kellerton, Iowa. I have spent some time in Ringgold County, looking up local records. The listing of George Harriman's descendants in Appendix C details what I know about the children and grandchildren of George Harriman who remained in Iowa.

## Harrimans and Ruckles in Minnesota

Neither George Harriman nor John W. Ruckle are listed in the first Minnesota census made in 1857. Harriman's obituary places the move to Minnesota in 1859. In the 1860 Federal census, Ruckle shows up as a 25 -year old laborer in Vernon Township of Blue Earth County. In the same census, in nearby Shelby Township, is the family of George Harriman (misspelled "Harryman"), his wife Eliza, and his three children, "Arrina" (Irena), age 10, Mary, age 3, and Julietta, age 1.

Harriman is a 30-year old farmer from Pennsylvania with $\$ 200$ in personal property. His wife Eliza, age 27, is also from Pennsylvania. Eliza's maiden name (determined from her children's wedding certificates in Ringgold County, Iowa) was Eliza Jane Johns[t]on. The census says that the oldest two daughters were born in Ohio, and the youngest in Minnesota.

Minnesota collected state census data in the early years at the 5 -year mark between the federal censuses. In 1865 George Harriman is still listed in Shelby, Blue Earth County. Living with him is his wife Eliza Jane and Irene, Ellen (i.e., Mary Ellen), Julietta, Benjamin S. and George. Not much information was recorded for the tallied families, however. All we learn about the Harrimans is that two boys had been added to the family since the 1860 census.

John W. Ruckle must have married the oldest child of George Harriman, Irena, about 186667. I have not been able to find a marriage record. On 1 September 1869 George is issued a land patent at Winnebago City for 160 acres in the NW quarter of Section 11, Township 105, Range 28. On the 1870 Federal census for Minnesota John Ruckle is a married man, living in Blue Earth County. His wife is listed as I. Ruckle, age 21, and they have a child Ida E., age 2. "G." Harriman is listed as 46 in the 1870 census, and "E. J.," his wife, as 40. Eliza, we learn, was born in Ohio, not Pennsylvania as the previous Federal census listed. "M. E.," Mary Ellen, is 13, "J.," Julietta, is 11, Benjamin is 8, "G. W.," the son George, is 5, and "M. Viola," Maggie, is 3. This is the last Minnesota census record I have been able to find for the George Harriman family in Minnesota, though there are land records which show a "Geo. Harriman and wife" in the act of buying and selling in the years $1865,1870,1871,1874$ and 1875. Since the Harrimans do not appear on the 1875 state census, I would assume that they moved to Iowa in 1875 (in which year, as we noted above, they purchased land in Ringgold County). George Harriman's obituary says that they moved back to Ohio in 1874, then on to Iowa in 1875. The daughter Irena did not move with them, however. John Ruckle and Irena are in Shelby Township in Blue Earth County, Minnesota, for the 1875 census. John is now 40, Irena is 26, and Ida is 7. 'John W. Ruckle and wife" appear on land transactions for the years 1872 and 1873. John and Irena’ second child, Ella, was born while they were still in Minnesota, so it is possible that Irena's pregnancy and the care of an infant kept them in Minnesota until 1876 or later.

For pictures of George Harriman and Eliza Jane Johnston taken, perhaps, in the 1870s, either in Minnesota or in Iowa, see Appendix D.

While in Minnesota, Harriman was a member of the U.S. Army. It was during the Civil War, but Harriman's unit was assigned to deal with the Indian uprisings in Minnesota in this period, so he may not have seen any of the major action of the war.

## Harrimans in Ohio

As noted above, it is clear from the Harriman and Ruckle census entries that George Harriman came from either Ohio or Pennsylvania, and for a time this was all I knew about the Harrimans before their Minnesota period. My first real clue about the exact locations of the Harrimans in Pennsylvania and Ohio came from a one-paragraph biography of George Harriman which was published by the local Ringgold County, Iowa, newspaper, the Record. In a supplement entitled "Prominent Persons of Ringgold County," published in 1880-81, the paper records that

George Harriman was born in Washington County, Pennsylvania, in 1828. His people moved to Licking County, Ohio, in 1834. In 1860 he went to Whiteside County, Illinois, the same year he came to Clinton County, Iowa. In 1861 he moved to Blue Earth County, Minnesota, and thence in 1876 to this county. He owns a valuable farm of 100 acres in north Athens, of which he is making a lovely home. Over 400 apple trees planted by him are beginning to bear. He is preparing to build a large house and expects to get it up within a year. During the Indian trouble in Minnesota in 1862-3-4 he served in the U. S. Army under General Sibley, who was sent out against the hostile tribes. He expects to deal largely in stock in a few years. He is a Republican.

This short piece is invaluable for tracing the movements of the Harrimans, although some of the dates may be off a bit. They all seem a year or two high when compared with dates in George Harriman's obituary, where the move to Clinton County, Iowa, is placed in 1857, the move to Minnesota in 1859, and the move to Ringgold County in 1875.

Licking County, Ohio, where George Harriman lived from about the age of six until he was past thirty, and where he presumably met and married Eliza Jane Johns[t]on, lies just east of Columbus, Ohio. The Harriman clan who came there from Pennsylvania in the 1830s continued to reside there for many years. ${ }^{7}$ The Licking County records may be a useful source for further information on the family. I have, however, only scratched the surface of the Licking records. ${ }^{8}$ George's daughter Mary Ellen, who was born in 1857, says that she was born, not in Licking, but in neighboring Knox County, Ohio, so some records on George Harriman may be located there. ${ }^{9}$

Censuses in 1860 and later are of no help in finding George Harriman's parents, because George was already out of the house, the head of his own family. Censuses in 1840 and before are of no use because they do not record the names of children, only the names of the heads of

households. The 1850 U. S. census, however, might potentially locate George in his natal family. We know that George Harriman was in Licking County in 1850. I did a search in the 1850 census for Licking County, Ohio, to see if I could find George.

In the 1850 Federal Census of Ohio there are two Licking County Harriman families of the right vintage to be George Harriman's natal family. One actually contains the name George. It is a family whose head, in the 1850 census, is Jane Harriman of Eden Township, Licking County. Jane has seven children living with her, ages 11 to 22 . Here is the entry:

It is possible describe this family more fully by consulting other sources. The father of the family, already dead in 1850, was Mason Harriman. Mason was born in the 1790s in Washington County, Pennsylvania. While still a young man he married Sarah Jane Martin (b. 1797, d. 1860). ${ }^{10}$ In 1825 there is a Washington County record that shows Mason and Jane sold his land to Mason's brother Samuel. ${ }^{11}$ Sometime after this sale Mason and Jane moved to Ohio. The 1830 census for Muskingum County, Ohio, locates Mason and Jane in Perry Township, living with two male children, an old man in his 70s (possibly Mason's father), and three female children. One of the male children is probably Alexander, ${ }^{12}$ the other David, ${ }^{13}$ both of whom would be later noted, as we see above, on the 1850

count. Two of the three female children in 1830 are the Hannah ${ }^{14}$ who is also on the 1850 census, and Margaret (wife of Simeon Brown), ${ }^{15}$ who is not on the 1850 census because she was already out of the home. The other daughter, whose name is not known, would have been born 1815-1820 or 1820-1825. In the 1830s Mason and Jane may have moved from Muskingum County to nearby Licking County: on the 1840 census Mason is probably the "Mason Harrison" in Eden Twp, Licking County. In the 1830s, as we can see by the 1850 census, four more children, Smith, ${ }^{16}$ Adam, George and Micha ${ }^{17}$ were born.

Mason's family is of interest in our search, but Mason's son George, born about 1839, is too young to be the George Harriman we are tracing. Our George, I believe, actually belongs to the family of Mason's brother, Samuel. Samuel and his wife Margaret are on the 1850 census, living near Jane Harriman and her family. Samuel was born in 1795 and his spouse Margaret was born circa 1798. ${ }^{18}$ They have at home two children, Washington, born circa 1832 in Ohio, and Catherine, born circa 1837 in Ohio. No George is mentioned. But a reconstruction of the children of Samuel and Margaret shows that our George could have belonged to the family and have moved away from home before 1850. In addition to these two children listed as living at home on the 1850 census, Samuel and Margaret Harriman may have had seven other children. Three are easily identifiable. They had a daughter Elizabeth ${ }^{19}$ who was born in 1829 in Pennsylvania. A Robert H. Harriman, age

33, who is living next to Samuel and Margaret, is another son..$^{20}$ A second son is John C. Harriman. ${ }^{21}$ Finding the rest of the children requires some careful census work. Samuel and Margaret first appear in the Washington County, Pennsylvania, census of $1820 .{ }^{22}$ By 1830 Samuel and Margaret Harriman have joined Samuel's brother Mason in Ohio, confirmed by the entry for Samuel on the 1830 census of Muskingum Co, Perry Twp. ${ }^{23}$ Of the five children for Samuel and Margaret mentioned above, two (Washington and Catherine) would not be on the 1830 census because they were born after 1830. The three others for whom we have names, Elizabeth, John and Robert, can be matched up to the 1830 list of children. The 1830 census suggests that Samuel and Margaret had, in addition to these three, three more boys, one born in the 1825-1830 period and two others born in the 1820-1825 period. The one born in the 1825-1830 period is very likely the George Harriman that we are

[^7]following in this paper. ${ }^{24}$ Possibly one of the two boys born in the $1820-25$ period was named Stephen. ${ }^{25}$ Here, in summary, is a possible reconstruction of Samuel and Margaret's family:

Samuel Harriman, born 1795 in Pennsylvania, m. Margaret Elliott ${ }^{26}$ before 1817 in Pennsylvania. Children:
(1) Robert H Harriman., b. circa 1817 in Pennsylvania, m. Adaline.
(2) John C. Harriman, b. 1818, d. 1894, m. Rachel A.
(3) Daughter, died young? ${ }^{27}$
(4) Stephen Harriman?, b. ca. 1820-25, m. Mary.
(5) Son, b. ca 1820-25?
(6) George Harriman, b. circa 1828 in Pennsylvania, m. Jane Turney, Eliza Jane Johnston, Lucinda Ellen Keller.
(7) Elizabeth Harriman, b. 1829 in Pennsylvania, m. George Stasal.
(8) Washington Harriman, b. circa 1832 in Ohio.
(9) Catherine Harriman, b. circa 1837 in Ohio.

## Harrimans in Pennsylvania

If Samuel is the father of George, and Mason is George's uncle, who is the father of Samuel and Mason? The answer to this lies in Washington County, Pennsylvania.

When I looked up all of the Harriman references I could find in Washington County, Pennsylvania, I discovered that there were four Harrimans who were there by about 1785: Robert,

Simkin (spelled various ways), George, and David. ${ }^{28}$ I have worked out a chronology in Appendix B for each of these which links the known citations for these Harrimans to date sequences. Four Harrimans are reported to have moved from Baltimore County, Maryland to Washington County, Pennsylvania, after 1778. ${ }^{29}$ Their names were Robert, James, David and George (more on the Maryland records the next section). If we assume that James is Simkin, ${ }^{30}$ then the records I found in Washington County are of these four Harrimans.

Which of these four Harrimans is the father of the Licking County Samuel? I searched the records of Washington County, Pennsylvania, thoroughly, and could not turn up any Pennsylvania document which told me what were the names of the children of the Harrimans who came from Maryland to Pennsylvania. But information which has come into my hand from other sources ${ }^{31}$ seems to indicate that David was the father.

Before we look at David, let's survey the other three Harrimans who came from Maryland. First, George Harriman. There is a document from Carroll County, Ohio, which tells more about him. It appears that George Harriman, who married a Rebecca, moved from Pennsylvania to Carroll County after 1820 . George's 1836 will suggests that he had no natural children. ${ }^{32}$

Second, James ( perhaps James Simkin) Harriman. A family chart of the Parker and Harryman families ${ }^{33}$ says that Simkin was born about 1756 in Maryland, died in 1833 in Harrison County, Ohio, and married Agnes, Ann and Mary. He had the following children:

(1) James Harriman, b. before 1791.
(2) David Harriman, b. circa 1794.
(3) Robert Harriman, b. circa 1793.
(4) Daniel Harriman, b. circa 1795.
(5) George Harriman, d. in infancy.
(6) William Harriman, b. 1797, m. Sarah Cooper in 1826, d. 1870 in Indiana.
(7) Simkin Harriman, b. circa 1804. ${ }^{34}$
(8) Charles Harriman.
(9) John Harriman.
(10) Benjamin Harriman, d. in infancy.

Simkin, by the way, ended his days in Harrison County, Ohio. Land records there show him buying a large farm ( 325 acres) as early as 1809, and selling pieces of it in the 1817-1824 period. He died still owning about a third of the original farm and is buried on the farm. ${ }^{35}$

Third, Robert Harriman. Robert had children already in 1790, and seems to have died, or to have sold out and left Washington County, around 1805-10. No information is available on his family. It is possible that this Robert may be the father of George, David and Simkin and not a brother (more on this in the next section).

Finally, the fourth of the Washington County, Pennsylvania, Harrimans, David Harriman. I have two lists of the children of David. After combining them, and applying some other data, I posit the following family for David: ${ }^{36}$

John Cuthbertson Harriman, b. ca. 1800, married Mary. ${ }^{41}$
In the lists I have, Samuel and Mason are cited near the beginning of the names, but they must be the last children in the family, born in the mid-1790s.

David may have moved to Harrison County, Ohio, in the late 1820s, ${ }^{42}$ perhaps to live with his son Mason. ${ }^{43}$ David's wife Elizabeth died in Washington County, Pennsylvania, in 1818. ${ }^{44} \mathrm{He}$ may have had a second wife, Sarah Adams. ${ }^{45}$

[^12]I note that the maiden name of Samuel's wife Margaret was Elliott, the same surname as that of Samuel's sister's (Catherine's) husband. Could Patrick Elliott and Margaret Elliott have been brother and sister? ${ }^{46}$

## Harrimans in Maryland

I began with my grandmother, Ella Etta Ruckle, and followed her back to her mother, Irena Harriman. I next followed the trail from Irena to her Pennsylvania-born father George Harriman. At this point the exact ancestral track is obscured, but it seems almost certain, for reasons outlined above, that George is a son of Samuel and Margaret Harriman, and that Samuel is a son of David Harriman. Having arrived at David Harriman, the trail now leaps eastward, from Pennsylvania to Maryland.

For background on David and Robert Harriman I turn to the genealogy done by Ethel Harryman. ${ }^{47}$ The first Harriman in Maryland is John Harriman. He shows up on a 1692 tax record, after which he starts to appear in a new series of tax records and in the deed registry. The location of John Harriman's lands seems to be just east of the present bounds of Baltimore, Maryland. The words "Thorrell's Neck" and "Back River" occur frequently.

Nothing is known about John's ancestry, or from what place he came to the colonies. There were Harrimans in the American Colonies from earliest times. Two genealogies I know of ${ }^{48}$ chronicle the extensive New England families descending from a John and Leonard Harriman. They were Yorkshire Puritan brothers who came to America in 1638. It seems unlikely that a Maryland plantation owner might have come from Puritan stock. There were other Harrimans who came into Maryland as indentured servants which might be more likely sources for John (providing John himself is not a direct immigrant).

John Harriman died in 1711. From his will we learn that his wife's name was Eleanor (she remarried to William Farfar, and died before 1733). The oldest of his children was born about 1694, so John and Eleanor may have married about 1693. Their children were:
(1) John, b. circa 1694, d. 1748, married Alice. Children: Prudence, Mary, Elizabeth (b. 11 September 1721), Jemima (b. 17 October 1724), John (b. 14 December 1727), Charles (b. 25 June 1730) and Thomas (b. 20 January 1735).
(2) Samuel, b. circa 1696, married Jane Smith on 18 August 1723, Comfort Taylor on 3 June 1728. Children: Eleanor (b. 25 February 1728), Ruth (b. 26 March 1731), Elizabeth (b. 18 December 1733) and Sarah (b. 12 July 1736).
(3) Thomas, b. circa 1700, d. circa 1733, married Elizabeth Norton.
(4) George, b. 1702, d. 1774, married Anne Wilkinson on 30 March 1725. Children: George (b. 19 April 1728), Sophia, Patience (b. 5 February 1733), William (b. 25 September 1736), Tamar, and Ann (b. 2 June 1742).
(5) Charles, b. 1704. No known wife or children.
(6) Robert b. 1710. See below.

John was a tobacco farmer, the owner of several plantations. Some of his children were in their minority when he died. The youngest is not mentioned in the will, so he may not have been christened yet (or perhaps not even born) when the will was drafted.

It is the youngest child, Robert, who may be the source of the Washington County, Pennsylvania, Harrimans. He married Elizabeth Simkins on 24 January 1733 in St. Paul's Episcopal Church in Baltimore. ${ }^{49}$ Elizabeth, who was born about 1713, was the daughter of John and Priscilla Simkins. John and Priscilla Simkins, besides Elizabeth, had John, Avarilla, Mary and Hannah.

Robert Harriman and Elizabeth Simkins had at least the following children: ${ }^{50}$

Robert and Elizabeth owned several tracts of land in Maryland, in Essex Parish, on the south side of Gunpowder River.

In 1778 a Robert, David, James and George Harriman took an Oath of Fidelity to the State of Maryland. They were from Middle River Lower, which places them in Essex Parish. The Essex location suggests that the oath-takers were from Robert and Elizabeth Simkins's extended family.

But how are they related? Three possibilities suggest themselves. First, Robert and Elizabeth Simkins may have had three more male children after Rachel who were not recorded in the parish register. All of the Washington County, Pennsylvania, Harrimans seem to have been born before 1755, so this only requires us to stretch Elizabeth Simkins childbearing over a 20-year period. There were several land transactions for Robert and Elizabeth in the early 1740s which may show them moving to another place in Maryland, and losing contact with the St. Paul Parish, so later children unlisted in a certain parish record might be plausible. The four oath-takers could have been the elder Robert and three sons, or, more likely, the younger Robert and three brothers. The second possibility is that Robert's son Robert may have married early and have had David, James ${ }^{51}$ and George in the 1750s. The third possibility (as speculated in the Ethel Harryman genealogy) is that Robert's son Robert had at least four sons, including the four oath takers. The first and third possibilities, where Robert is a brother of the others, seem more plausible, since Robert had, as did some of his other brothers, children under 16 on the 1790 census. The first explanation, in turn, seems more likely than the third, since it accounts more readily for the name Simkin in Robert and Elizabeth's family (direct children are often given Christian names consisting of the first and last name of someone in the mother's family).

If this last guess turns out to be correct, then the David or Robert Harriman, whom we are speculating is the great-grandfather or grandfather of the George Harriman who came to Ringgold County, Iowa, has the following line of ancestry:

If a child became a source for a new entry (i.e., married and produced children), then only the name is given and an Arabic numeral to the left of the entry points to the entry in the next generation with that person's full information. ## Appendix D: George Harriman Pictures

These two pictures are, I believe, George Harriman and his wife Eliza Jane Johnston. They would have been taken before Eliza's death in 1880 .

A picture, taken, I believe, in Kellerton, Iowa. The older man in the chair is George Harriman. On his right, our left, is his daughter, Mary Ellen Harriman Ruckle. On his left, our right, is probably his granddaughter, Edith E. Ruckle, daughter of Mary Ellen Harriman and David Louis Ruckle and granddaughter of George. Edith would have been about twenty-six in 1911. Edith had a child, Mary G., who would have been three or four in 1912-she may be the one standing in front of Edith. If we assume the picture was taken in late 1911 or early 1912, in the last year of George Harriman's life, George would have been about ninety.

On this and the next page are pictures that I believe to be the three daughters of George Harriman. The two young children in the picture on the left are probably Mary Ellen and Julie Etta Harriman. On the back of the picture is stamped "J. McCohon, Photographer, Utica, Ohio." Someone has written on the back in pencil, "1865." In 1865 Mary Ellen would have been about eight, and Julie Etta about five.

The picture on the right I believe to be either Irena Harriman, the oldest daughter of George Harriman and Eliza Jane Johnston, perhaps taken about 1880, when she would have been thirty, or Julie Etta Harriman, the third daughter, taken in the 1890s.


The family on the right is Mary Ellen Harriman and her husband, David Louis Ruckle, and their two children, Fred Oliver and Edith E. Taken about 1890. Mary Ellen, Betty Organ writes, was only four foot nine inches tall with blue eyes and auburn hair.

The couple on the left may be Mary Ellen Harriman's daughter Edith E. and Edith's husband, James H. Ruckle, taken about 1908.

[^1]:    ${ }^{2}$ On 2 June 1999 I was contacted by Connie Jones, $90820^{\text {th }}$ St., Wheatland, WY 82201 (sfj@btigate.com) about the son George (George Welcome Harriman). He was born 6 Oct 1864, died 23 Apr 1957, and married Nellie E. Burns, daughter of Thomas Burns and Nancy Fender(sp?) on 4 Feb 1892. Their son Leroy Lee Harriman married Mary Lillian Lynch, and had a child James and a daughter JoAnne Jewel (m. Delvin Eugene Jones). Leroy was suppose to have married a second wife. James and JoAnne were adopted and raised by Mary Lillian's brother and wife who were Joseph Preston Lynch and Emma Jewel Lynch. George W. Harriman and Nellie had another son, Lester Burns Harriman, b. 25 May 1897, m. Alma Luella McDowell (1903-1993), d. 29 June 1980. They had 8 children and lived in Cresston, Iowa (Union Co). George W. and Nellie also had a son Elmer L. Harriman, who married Myrtle M. Morss on 6 November 1915. A Bertie Harriman, d. 11 Nov 1985 and buried beside George and Nellie, may have been a child of theirs who died young. Nellie died on 6 Nov 1905 at the age of 33. The Ringgold Co., Iowa, marriage records show George W. remarrying on 24 April 1907 to Minnie Miles, age 41.
    ${ }^{3}$ Ellen is Ellen Keller, daughter of Daniel and Thursday Keller, b. in Terre Haute, Indiana in 1851, died 21 June 1929 (from obituary). For a picture of her, see Appendix D.

[^2]:    ${ }^{4}$ I have been working with some of Daniel's descendants to establish the relationship between David Louis and John W. Ruckle. Quite a bit of circumstantial evidence has emerged to indicate that they are two of the three sons of Daniel Ruckle and Rebecca Jarrett of Monongalia County, West Virginia, but no document has turned up which states their exact relationship.
    ${ }^{5}$ I have no record of George Harriman owning a part of this section. His farm bordered this section on the north. It could be he was renting a house in a section neighboring his farm. It could also be that there is a slight mistake in the census.

[^3]:    ${ }^{6}$ Irena's father is said to have been born in Ohio on this census. This conflicts with the information George gave 15 years earlier, that he had been born in Pennsylvania. Remember, however, that Irena was born in Ohio, and had lived there until she was 9 . She may have assumed that her father and mother had also been born there.

[^4]:    ${ }^{7}$ In the 1890 s the local newspaper in Ringgold County, Iowa, noted that George's son Benjamin Harriman had received an invitation to attend the first annual reunion of the Harrimans in Columbus, Ohio.
    ${ }^{8}$ Another Harriman researcher has told me that many of the Licking records were lost to fire, however.
    ${ }^{9}$ Cited in the Civil War pension papers of her husband, David Louis Ruckle.

[^5]:    ${ }^{10}$ Sarah is buried in Bell Cemetery, Morgan Twp, Licking County, Ohio. The dates are from her tombstone. In 2007 Richard Patten (owenpatten@woh.rr.com) sent me information about a document in the Licking County Library in Newark, Ohio, called "A History of Eden Township, Licking County" It is handwritten by Dealia Hawk and was given to Gladys Oldaker Berger. The notebook contains an oral history of the pioneer neighborhoods of Eden Township. In the document we read that "Moses Jewell married Micha Harriman, a daughter of Mason Harriman whose farm joined the Jewell farm on the north. The house stood on the hill, the first one north of the creek. At that time the Brown family lived across the road west of the Harriman House. This farm later came into the possession of Alexander Harriman, a brother of Micha. William Jewell married Barbara Aden, moved to Utica, later to Newark where he died February 24, 1915. Both Moses and William Jewell were carpenters. Keziah Jewell married John Martin, a brother of Mrs. Mason Harriman. . . ." So it appears that Sarah's surname was Martin.
    ${ }^{11}$ Book 2-K, p. 256, of the Washington County, Pennsylvania, land records.
    ${ }^{12}$ Alexander is also buried in Bell Cemetery. He was born in 1824 and died in 1899. Three others buried in the same plot, Smith (d. 1920), Rachael (1863-1931), and Richard (1855-1932), may be the children of Alexander.
    ${ }^{13}$ David is also buried with the Mason and Jane family in Bell Cemetery. He was born in 1828 and died in 1850.

[^6]:    ${ }^{14}$ Susan Gordon, SznGordon@aol.com, is a descendant of Hannah and looking for further information on this line. Susan writes that Hannah was born 10 April, 1828, and died 5 March, 1891 Hannah's husband was Edward Penick, b. March 1, 1824, d. May 24, 1909, buried at the Eden Church Cemetery, Eden Twp, Licking Co, Ohio.
    ${ }^{15}$ A descendant of Sarah Jane Martin and Mason Harriman, Frances M. Burnham of 1512 Roselawn Avenue, Stockton, California 95204, put an inquiry in the Licking Lantern, Vol. VII, No. 1 (Winter 1982), p. 27. The name of Margaret's husband is also in a letter written by Robert Franklin Dush in 1950. The Dush letters were sent to me by Ken Burroughs (kennibee@aol.com).
    ${ }^{16}$ The Dush letters mention the son Alex and Smith. Smith, according to an obituary on file in Licking County, died on 10 January 1888, age 57 years.
    ${ }^{17}$ Micha, the Dush letters say, married Mose Jewell.
    ${ }^{18}$ Samuel's birth date, besides being on the 1850 census, is also on his tombstone in Souslin Cemetery.
    ${ }^{19}$ She is mentioned in the History of Licking County, Ohio (1881) by N. N. Hill, p. 764. She married George Stasal of Germany on 30 December 1848. In the historical volume Licking County, Ohio 1982, Vol. I (by the Licking County Genealogical Society), p. 482, a descendant of Elizabeth and George gives her dates as 1829-1906, and says that she was born in Pennsylvania.

[^7]:    ${ }^{20}$ He was born in Pennsylvania. His wife, Adaline, was born circa 1825 in Ohio, and their children, according to the 1850 census, are Emily F. (born circa 1843), George (born circa 1845), and Naomi (born circa 1848), all born in Ohio. According to an Ancestry.com family tree (documentation unknown) Robert and Adaline also had Nettie (m. John Conklin) and Julia A. Harriman, b. ca 1863.
    ${ }^{21}$ In the Dush letters the writer mentions that he had learned from his grandfather, a nephew of Samuel and Mason, that Samuel was the father of "John and Bobby Harriman" who lived "in the Marg Weiss vicinity." Four members of Samuel and Margaret's family are buried in Souslin Cemetery of Eden Township, Licking County, Ohio. Samuel is there, and his dates are 1795-1851, so he died the year after the census was taken. Also buried with Samuel is John C. Harriman (1818-1894) and his wife Rachel A.(1826-1874).
    ${ }^{22}$ The 1820 census for Washington County has an "S. Herriman." There is an adult male and female, 25-45, who are probably Samuel and Margaret. There is another male $45+$ in the household, and there are three boys and a girl under ten. Two of the boys may be Robert and John. A third might be one of the boys born 1820-25, if born in 1820 (see below). The girl under ten is unknown. In the 1820s Samuel and Margaret were living in an area called "Cross Creek." This is documented in the sale of land to a Mary Stewart, 20 September 1826, Book 2-M, p. 32, of the Washington County, Pennsylvania, land records. This may be the same land that Mason and Jane Harriman had sold to a Samuel Harriman in 1825.
    ${ }^{23}$ The birth places of the children Washington (1832, Ohio) and Margaret (1829, Pennsylvania) suggest that the move from Pennsylvania to Ohio happened not long before the 1830 census. Around 1840 Samuel and Margaret left Muskingum County, Ohio, and moved to Licking County, Ohio. There is an Ohio Land Patent for Samuel Harriman dated 1 Aug 1842: "Samuel Harriman of Licking County registers at Zanesville OH his deed of land for 40 acres in the NE quarter of the NE quarter of Section 13, Township 4, Range 11 of the Military District."

[^8]:    ${ }^{24}$ George, we know, was born in 1828 in Pennsylvania, and he says that he arrived in Ohio about 1832-33 (subtracting a year from the biography date of 1834 to account for the one-year shift in the other dates). As we have seen, George must have come to Ohio before 1830. A strong piece of evidence that Samuel and Margaret are George's parents turned up when I saw George's death certificate. The name of his father is just Harriman, but the name supplied for his mother is Margaret Elliott. No other Margaret Harriman of Licking County is known, especially not one with a known son born about 1828.
    ${ }^{25}$ In Ringgold County, Iowa, where George Harriman settled, there is a will record in the county will book covering 1858-80 for a Stephen Harriman, who left everything to his wife Mary. Mary is mentioned in the 1880 census records for Athens Twp, the same township that George lived in. She died on 7 April 1888 and is buried in Ringgold County's Patrick Cemetery. Stephen could be one of George's unidentified brothers.
    ${ }^{26}$ Margaret's last name is based on George Harriman's death certificate. As we will see in the next section, the last name is another hint that George's mother is connected to Mason and Samuel's families.
    ${ }^{27}$ Guess based on the appearance of a girl on the 1820 census who is not on the 1830 census.

[^9]:    ${ }^{28}$ A John also appears by 1793 , but he may be the son of one of the others. He is perhaps John Culport, the son of the brother David.
    ${ }^{29}$ This story of the four brothers is taken from a 1977 genealogy by Ethel Harryman, Box 211D, Douds, Iowa 52551, entitled Elijah Harryman: His Descendants and Ancestral Background, 1661-1977.
    ${ }^{30}$ In the 1836 will of the brother George Harriman in Carroll County, Ohio, he mentions that the name of Simkin's son is James Simkin. This suggests that some of the many Simkins in this family may in fact be James Simkins. The name widely-occuring name Simkin among the Harrimans may be derived from John Simkins, whose will was probated in 1739 in Maryland (Maryland Calendar of Wills, Vol. 8, p. 20), and whose daughter Elizabeth married a Harryman. Further discussion on this family below.
    ${ }^{31}$ I refer here to the Ethel Harryman genealogy listed above, unless otherwise specified.
    ${ }^{32}$ There were three children whom he "adopted" (the phrase is "a boy/girl that I raised"): George Liggett, Thomas Scott, and Nancy Faylor (Taylor?). The will confirms that Simkin was his brother.
    ${ }^{33}$ Also from the Ethel Harryman genealogy.

[^10]:    ${ }^{34}$ The family chart in Ethel Harryman's genealogy shows what is probably this Simkin's family attached to his cousin Simkin, the son of David. This Simkin, son of Simkin, married Sarah Cox in 1824 in Tuscawaras County, Ohio (from correspondence with Helen McDowell).
    ${ }^{35}$ Data cited in correspondence from Ethel Harryman.
    ${ }^{36}$ The first list of David's children is an appendix in the Ethel Harryman genealogy. The second list is in the DAR application of Avis Fisher Kelly, in a deposition given in October, 1910. Harryman's list is partly dependent on Kelly's list. For some reason Harryman has added a son George that Kelly has omitted. The birth dates in the Ethel Harryman genealogy are, I think, mostly wrong, since they make Samuel and Mason twenty years older than the dates they report on the censuses.

[^11]:    ${ }^{37}$ Baskin's History of Logan County, Ohio (1880) tells about a Simkin and Sarah Green Harriman of Washington County, Pennsylvania, whose parent was a David Harriman who was born in Maryland. The county history says that Simkin and Sarah had thirteen children and that Simkin was born in 1788, married in 1806, immigrated west from Washington Co., Pennsylvania, in 1825, and died on 4 Feb 1872. Sarah Green died in Oct 1868, it also says, and her mother was Phoebe Kirk, who married Nehemiah Green, a Revolutionary War veteran. The Logan County history has further information on Simkin and Sarah's sons David and Stephen. Helen McDowell, who researches the Simkin/Sarah line, and has a complete list of Simkin's and Sarah's children (Helen dates Simkin's birth, by the way, as 1784-I'm not sure why). Helen records the surviving children as David Harriman, b. 1817 (m. Harriet Watkins), Rhoda Fisher, Stephen Harriman (b. 1817), Margaret Ely (m. Amos Ely), Lydia Southard, Sarah A. Johnson (m. George Johnson), William Harriman, Mary Drake and John Harriman. Three daughters, two of whom were named Phoebe Kirk Harriman and Elizabeth Harriman, died young. Her data is taken from the minutes of the meetings of the Harriman reunion from 1915 to 1938 . Note that the reconstruction of this family in the Ethel Harryman genealogy shows a family for this Simkin that should probably be attached to his cousin Simkin, the son of Simkin.
    ${ }^{38}$ The marriages of Emelia, Delilah and Catherine are taken from the DAR application.
    ${ }^{39}$ Catherine's cemetery marker in Martinsburg, Ohio, says that she is "Catherine Wife of Patrick Elliott" and that she died "June 3, 1857, aged 67." In the 1850 census for Knox County, Clay Township, Ohio, her age is 58. Catherine's pension record of 22 February 1856 says "Catherine Elliott aged Sixty three years...." This data is from a 19 February 1982 letter of John N. Furniss, passed on to me from Ken Burroughs. The Dush letters, also transcribed and sent to me by Ken Burroughs, and cited earlier, specifically mention that Samuel, Mason and Catherine are siblings, and give the names of some of Mason's children (Smith, Alex, Margaret who married Simeon Brown, and Micha, who married Mose Jewell) and some of Samuel's children (Robert and John). The Dush letters list the children of Patrick and Catherine as James Miller Elliott, Elliza Elliott Bricker, David Harriman Elliott, Mary Porterfield-McKee Elliott, and Samuel Scott Elliott.
    ${ }^{40}$ The Avis Fisher Kelly list identifies this as the David Harriman in Marion Co, Ohio, who married an Elizabeth Burnett and a Nancy Reed. This is probably incorrect. Although the Marion Co. David had a father David, his father was born much earlier, perhaps in the 1720s, and died in Darke Co, probably around 1820. Information on the Marion County David is in The History of Marion County, Ohio, 1883, by Leggett, Conaway \& Co. Sue Bixby has extensive research notes on the Marion County David. On Avis Fisher Kelly's list, David occurs at the end of the list. Helen McDowell, in personal correspondence with me, speculates that Kelly left David Jr out of David Sr's family "until someone who reviewed her application" included him. If so, then Kelly may have no source for David Jr other than the misidentified Marion Co. David.

[^12]:    ${ }^{41}$ Sue Bixby and Berkeley Harriman have been researching this family. On the basis of their research, I have removed John Culport, b. 1772, from the list, and added John Cuthbertson, b. ca. 1800. John Culport Harriman on the list of Avis Fisher Kelly was born too early (ca. 1772) to be in the family. John married Mary Brown. John and Mary's family is in the LDS Ancestral File, in data submitted by Dorothy E. Yarbrough, P.0. Box 753, Joshua Tree, California 92252. According to Yarbrough, the children of John and Mary are:
    (1) Simkin, b. 1794 in Pennsylvania, d. 1894 in Missouri. Simkin married a Mary Proctor (b. 1794, Kentucky).
    (2) Margaret D., b. 1795 in Pennsylvania, d. 1885 in Missouri.

Helen McDowell notes that in the Preble County, Ohio, census of 1840 David is listed as a Revolutionary War soldier who is 80 years old. A plaque in the Preble County courthouse mentions his name.
    ${ }^{44}$ Elizabeth's death announcement in the Examiner Records, Vol. I, Marriages and Deaths, 1796-1833, Washington, PA," says that she "left a family of nine children."
    ${ }^{45}$ Perhaps David remarried soon after his wife Elizabeth died in 1818. An 1819 Hopewell Twp, Washington Co, PA, land record says that a "David and Sarah" Harriman give land to Samuel Harriman "for love and affection." LDS Ancestral File, in data submitted by Dorothy E. Yarbrough (see above for reference), gives Maud Adams as David's wife. The Avis Fisher Kelly DAR application (see below for reference) gives the name only as Adams. A query in the Washington Co, PA, Keyhole by Helen McDowell gives the wife's (possible) name as "Sarah Adams." The 1820 Hopewell Twp census indicate that there is a woman aged 26-45 in David's household which may be this Sarah.

[^13]:    ${ }^{46}$ The Dush letters cited above say that Patrick's parents "came from Ireland or Scotland" and that he "migrated from near Washington County, PA to the John Ackley or Frank Penn farm south of Martinsburg, Ohio" where he was raised, and where he raised his own children."
    ${ }^{47}$ Elijah Harryman: His Descendants and Ancestral Background with Allied Lines, 1661-1977 (Fairfield, Iowa: Tribune Printing Co, 1977). I have cited data from this above. Much of my information on the Maryland lines (unless otherwise documented) is taken from this genealogy. Ethel Harryman made extensive use of research done by Clifford J.
