### **Abraham and Jacob Pitsenbarger: Documents and Chronology**

This summary is an attempt to put together the documents I have on my great-great-great-great-great grandfather, Abraham P\*, and his son Jacob P\*. Over the last three years other researchers have been generous in supplying me with documents and interpretations of how these relate to my family line. The following pages are in no way a finished product: the goal is to pull together into one place the documentary evidence for this line of ancestry in a form which can be sent out to other researchers. It represents, at this point, very little primary research on my part. I am adding to this summary as new material comes to light. If this comes to you as printed copy second-hand, you should contact me for the latest version. The version on the web is always the latest version.

I am interested in Abraham and Jacob P\* because they are the immediate ancestors of Anna Catherine P\*, who married Adam Rodabaugh. A fuller description of the life of Adam and Anna Catherine can be found in my summary "Abraham Rodabaugh, Ancestors and Descendants." Adam's ancestry is in my genealogy *Four Generations of the Immigrant Christian Rodabaugh* (1707?-1779) and his Family. My line of ascent to Anna Catherine is Kem Luther (1946-), Billie Enid Rodabaugh (1917-), William Henry Rodabaugh (1879-1964), Abraham Rodabaugh (1853-1937), Jacob Rodabaugh (circa 1820-after 1880), Anna Catherine P\* (circa 1794-after 1870).

There are a number of people who are active in researching various parts of the P\* line. In Appendix B I have provided a list of correspondents. In Appendix C I have listed all of the P\* sources currently in my files. At the end is an index of persons and places.

#### Chronology

Numbers in square brackets (e.g., [0]) are references to bibliographic sources in Appendix C. The first mention of any child of Abraham and Jacob P\* is in bold SMALLCAPS. I have given the death date for each child (if known) in the entry under the date of birth, and a forward reference to the marriage date. Spouse names and dates, and sometimes indications of data sources for descendants, are given in the marriage entry for each person.

- Abraham "Bitzberger," mason, marries Elisabet "Teysinger" (assumed Elizabeth Deisinger) at Trinity Lutheran Church in Lancaster, Pennsylavania, on 22 April. In another church record, a communicant's list, Elisabeth's mother is said to be "Margaretha Feisinger."[33]
- JACOBP\*, the oldest son of Abraham and Elizabeth P\*, was born on 23 February and baptized on 1 March. His sponsor was Margaret Schmidt.[33] As reported on his tombstone, he died on 9 July 1840 in Darke County, Ohio. His marriage was in 1792.
- December, 1768, is the year given for the birth of Jacob P\*'s future wife, Margaret Booher/Bucher/Butcher.<sup>1</sup>
- Abraham, Elizabeth and her mother (a widow) are listed as communicants of Trinity Lutheran Church in Lancaster County, Pennsylvania. [33]. Abraham is said to be 30 years old.
- ABRAHAM P\* JR, son of Abraham and Elizabeth P\*, was born on 14 Feb, baptized on 1 April. His sponsor was Peter Deisinger (possibly a brother of his mother).[33] Abraham P\* Jr lived in Pendleton County and Nicholas County, West Virginia, until 1830. After1830 he disappears from the census records, perhaps indicating the decade of his death was the 1830s. His marriage was in 1795.
- PETER P\*, the son of Abraham and Elizabeth P\*, is born on 14 February and baptized on 20 May, Peter Deisinger and Catherine Spohr, sponsors.[33] Peter P\*''s tombstone in the Yoder Cemetery, Darke County, Ohio, says that he died on 3 December 1837 at the age of 63 years. He married in 1804. His wife, Mary Magdaline Fry, is buried in Clinton County, Indiana. Her tombstone says that she

died on 22 May 1853 at the age of 73 years, 9 months and 29 days. Peter P\* moved to Greene County, Tennessee about 1803, and on to Wayne County, Indiana, about 1826/29.[24] Many of Peter P\*'s children ended up in Darke County, Ohio, where Jacob P\* lived. There were two first-cousin marriages between Peter P\*'s and Jacob P\*'s families.

1774-79

**ANNY P\*** and John P\*, children of Abraham and Elizabeth P\*, are born in the 1770s. See under 1792 for Anny's marriage.

1777

According to a Virginia deed [65] Abraham P\* bought 300 acres of land on Elk Run, a tributary of Stoney Creek, in Shenandoah County (then Dunmore County), Virginia. The house on this land, originally built in 1734 by John Cristy, still stood in 1937 [69]. The house is on the Shenandoah Alum Springs Road, about three miles south of Jerome, Virginia.

1775-79

My guess for the birth window of **JOHN P\***, son of Abraham and Elizabeth P\*.

1776-1781

Abraham P\* is recorded on an undated scroll as a member of the militia under the command of Captain Michael Reader [3]. It is not known which of the war years are included in this document. Also on the list is the Peter Tiesinger who would later witness Abraham P\*'s will.

1781

PHILIP P\*, son of Abraham and Elizabeth P\*, is born. Beer's history of Darke County [39], in the section on Patterson Township, says that "the first settlement was made in 1827 by Isaac Finkbone and upon the adjacent section a man named Philip Pitzenbarger erected a cabin and clearing a few acres lived for a time upon the land as a squatter. The location of these two pioneer clearings was Section 32 and 33." In 1830 a Philip P\* is living in Wayne Township. He is age 40-49, and has 1 boy and 2 girls under 5, 3 boys age 10-14, 1 boy age 15-19, 1 girl 5-9, and 1 girl age 10-14. If this latter reference and the son of Abraham and Elizabeth P\* are one and the same, then the birth of Philip P\* must have immediately preceded his father's death, since his father only lived for part of two years in the birth decade indicated on the census. It is interesting that to note that in the list of the younger children in Abraham P\*'s will, given three times, Philip P\*'s name is always the last boy. Philip P\*'s wife's name may have been Catherine.<sup>2</sup> The marriage date is unknown.

1781

On a single sheet which survived as a page marker in the Zion Pine Church (a German Lutheran Church in Shenandoah County) there is a list of persons who contributed to the retirement of the church's debt [70]. The name of

"Pitzenbarger" occurs. The first name is indecipherable, but it could be "Abram." If Abraham P\* had already died, it seems unlikely that his family would have been in a position to contribute, so this probably occurred prior to the summer of 1781.

1781

On the 12th of April Abraham P\* is sick and makes out his will [52]. It is not known how long he lived after making out his will, but the probate occurred in August, so it must not have been long. From his will we learn that his wife's name was Elizabeth (maiden name still unknown), and that his eldest son was Jacob P\*. His second oldest was probably Abraham P\* Jr. The will implies that both Jacob P\* and Abraham P\* Jr were under 21 (Jacob, the oldest, was in fact 14). They each inherited 150 acres of the land which had been purchased in 1777, and they were to "divide it in brotherly love." Elizabeth's one-third dower was reserved, as was usual. The other four children, Peter P\*, John P\*, Philip P\* and Anny P\*, were to receive cash payments from their brothers Jacob P\* and Abraham P\* Jr, paid out over a five-year period after the two boys had turned 21. The will was witnessed by George Rinker, Peter Tiesinger, Ubrick Waggoner and Nicholas Hellwick. Matthias Painter shows up as an executor with Elizabeth.

1785

The Virginia 1790 census figures for Shenandoah County were based on county enumerations from 1783 and 1785. Elizabeth shows up on a list made by Alexander Hite in 1783 [36] and on one by Jacob Rinker in 1785 [67]. Rinker lived in Conicville, so the people on the list were from there and adjacent areas. Elizabeth has in her family eight white persons in 1783, but only six white persons in 1785. The 1783 list seems to have one extra person, and the 1785 seems to be short: if the number six includes Elizabeth, as it seems to, then one child is missing. Perhaps Jacob P\*, already 18, was living off of the family farm.

1786

On 6 April Jacob P\*, listed as "Jacob Bizenberger," is the godparent for Johann Jacob Schäfer, son of Christian and Anna Schäfer. The baptism was in the Zion Pine Church, and was performed by Abraham Gottlieb Deschler [70].

1792

According to Morton [45], the marriage date for Jacob P\* and Margaret Booher/Bucher/Butcher. Margaret's parents are not known with certainty. In Appendix A is a discussion the Butcher possibilities for Margaret's ancestry.

1792

According to Morton's Pendleton County, West Virginia, history [45], the marriage date of Elizabeth P\* (probably the "Anny" of the will: if she were named Elizabeth Anne P\*, and her mother used the name Elizabeth, she might well have

been called "Anny") to John Moats.<sup>4</sup> The data on the marriages of both Jacob P\* (in the entry just above) and Elizabeth P\* is said to be "unplaced," so this citation should not be taken to imply that Jacob P\* or Elizabeth P\* lived in Pendleton County.

1793

Birth of **PHEBE P\***, daughter of Jacob and Margaret P\*. The 1810 census discussed below suggests that there were two daughters born before 1795. Since Anna Catherine P\* is known to have been born in 1794, it seems logical to put the first daughter in the empty two-year space after the marriage. Note that Phebe P\* and Anna Catherine were also the first to marry. Phebe P\* was married in 1817. When the final papers on the administration of the estate of Jacob P\*, the father of Phebe, were made out in December of 1858, Phebe P\* was deceased.

1794

Jacob P\* and Abraham P\* Jr, in twin deeds, sell the land they had inherited from their father as two separate 150-acre parcels [66]. It appears that they had not formally divided the land by deed, so the signatures of both were needed for each half. No mention is made of Elizabeth or her dower rights, so she may have died by this date. Jacob P\* was already married to Margaret, but no wife is mentioned for Abraham P\* Jr, so he must have been unmarried. A court order was issued on the 9th of July for two justices to travel to see Jacob P\*'s wife Margaret and obtain her consent to sell, since she was not able to travel. They made the trip and registered the consent on the 16th. It may be that the impediment to Margaret's travel was a pregnancy, since her oldest child may have been born only two weeks later (see next entry). The fact that the court would underwrite such a trip, and that it could be done so quickly, suggests that Jacob and Margaret P\* were living in travelling distance to the Shenandoah County land which they had inherited (see Appendix A for more).

1794

Birth of **Anna Catherine P\***, daughter of Jacob and Margaret P\*, according to her age on the 1850, 1860 and 1870 censuses. Correspondence with Emmalo Coody gives the specific day as 26 July [8]. On the censuses Anna Catherine P\* specified her birthplace as Virginia. She died after 1870, probably in Missouri. The site of her grave is not known. She married about 1815.

Before 1795

This is the time given in Morton's history [45] for the arrival of the P\*s in Pendleton County, West Virginia. The name of Abraham Jr P\* is known as the head of the Pendleton County group. The P\*s are said to have settled around Dahmer, which is near Sugar Grove, West Virginia. Abraham and his wife bought

the Nicholas Emick farm in 1799.<sup>5</sup> The Pendleton County tax lists show Jacob P\* owning land from 1794-96, and Abraham Jr P\* from 1797 on.

1795

The date in Morton [45] for Abraham Jr P\*'s marriage to Mary Cowger (pronounced COW-gurr). Their children are described in [19]. Other sources for the descendants are [41] [34] [35] [51] [50] [49] [46]. It is possible that Mary was the child of John Conrad Gauger and Anna Barbara Probst. John Gauger arrived in North America in 1736, and came to Virginia in the early 1760s [9].

1796

One source on the Cox line, into which Barbara P\* married, reports 27 October as the birth date for Jacob and Margaret P\*'s daughter **BARBARA P\*** [42]. It is only through the Cox descendants, in fact, that we know her name, since her father's will mentions only Barbara's son. The same source reports 4 April 1820 as the date of her death (in childbirth). See under 1820 for the date of her possible marriage.

1795-1803

Jacob and Margaret P\* may have moved to Pennsylvania on or before this date, since the child born in 1794 claims Virginia as her birthplace and the child born in 1802 claims Pennsylvania as his birthplace. However, the child Margaret, who may have been born in 1803, says that she was born in Virginia. It is possible (see Appendix A) that Jacob and Margaret P\* accompanied a large group that migrated west from Pendleton County in 1797.

1797-99

Birth of Jacob and Margaret P\*'s daughter **ELIZABETH P\*** ("Betsy"). The 1830 census for Randolph Township, Montgomery County, Ohio, places her birth in the decade of the 1790s. She married in 1821, and the 1810 census seems to imply a girl in the second half of the decade, so I am guessing that her birth falls in this period. Note that exchanging the names of Elizabeth P\* and Phebe P\* in the birth sequence does not produce any contradictions. Elizabeth P\* was married in 1821.

1802

The Beer's history of Darke County [39], discussing a daughter of Jacob's son Jacob Asbury P\*, says that **JACOB ASBURY P\*** was born in Pennsylvania on 18 August. This agrees with his tombstone in West Branch Cemetery, Neave Township, Darke County, which says that he died on 24 September 1878 at the age of 76 years, 1 month and 6 days. Jacob Asbury P\* was married in 1825.

1803

Jacob and Margaret P\*'s daughter **MARGARET P\*** born. On the 1850 census of Darke County Margaret Metzgar lists her age as 40, placing her birthdate close to 1810. She says, moreover, that she was born in Ohio, which would imply a birth

date even later, perhaps 1811. The 1860 census, however, has her age as 58, and her birth place as Virginia, which would move her back to about 1802/3. The 1810 census does suggest a girl was born 1800-1810. According to the Alva Pitsenbarger family Bible a Margaret "Metcar," probably this Margaret, died on 2 March 1865. She was married in 1827.

- Peter P\* and Mary Magdaline Fry marry on 3 January in Greene County, Tennessee.
- Jacob and Margaret's son **HENRY P\*** was born about this year, according to the information on the 1850 Darke County census. Davidson family group sheets (Henry P\*'s oldest daughter married a Davidson) specify the date as 10 November.[24] The date and place of his death is unknown. He was married in 1828.
- According to the 1850 Darke County census, Wayne Township, **JOHN D. P\*** was born in Pennsylvania about this year. His will was made out on 21 January 1863. He died within a month of making out his will, and was buried in Yoder Cemetery, but the stone has been reset, and the date of his death is obscured.[24] He was married in 1834.
- Jacob "Pitsonberger" is in Fayette County, Pennsylvania, in Bullskin Township. He is listed as being over 45, though he was only 44 if the information above is correct. Besides his wife, living with him are 4 boys under 10, one boy 10-15, 1 girl under 10, 2 girls 10-15, and 2 more girls 16-25. This corresponds to the ages and genders of children born to this date, except there are two extra boys, one under 10 and another 10-16. These may be relatives, or children who died.
- This would be the date that Jacob and Margaret P\* and their children moved to Ohio, according to Beer's history of Darke County [39].
- Jacob and Margaret's son **JONATHAN B.P\*** was born on 1 November according to an entry in the Heins-Pitsenbarger family Bible [13]. The same Bible lists his death date as 18 April 1886. He was living in Wayne Township, Darke County, Ohio. These dates also correspond to the dates on his tombstone in Yoder Cemetery, Darke County. He was married in 1839.
- Approximate date for the marriage of Anna Catherine P\* to Adam Rodabaugh, probably in Montgomery County. Adam was born circa 1788, and died about 1865. After 1842 Adam and Anna Catherine lived in Darke County, Van Buren Township.

1816

Jacob P\* is listed as a proprietor on the Randolph Township, Montgomery County, Ohio, tax records for this year [60].

1817

Jacob and Margaret P\*'s daughter Phebe P\* marries Daniel Fetter (or David Fetter) in Montgomery County on 25 September. On 2 May 1842 her brother Henry P\* is appointed guardian of the Fetter children of Phebe P\*. Pitsenbarger researchers have posited different life histories for Phebe over the years. The most recent study of this is by Wally Garchow, published in the *Darke County Kindling* (XII:4, Oct 1994). Wally believes that Daniel and Phebe had three children who lived to be adults, George Fetter, Margaret Fetter and Delila Fetter. Phebe P\* died between 1834 and 1841. Widower Daniel Fetter remarried, to Anna Barbara Shook, widow of Henry Shook, on 19 Sept 1841. Daniel Fetter died in early 1842 and his widower (of less than a year) married Jacob Waganick on 20 May 1842.[29]

1819

Approximate date of Barbara P\*'s marriage to John Cox. I did not find the marriage recorded in Montgomery County. However, the Coxes were Quakers, and the West Branch Monthly Meeting records show a John Cox was condemned for marrying contrary to discipline on 16 October 1819 [68]. John Cox was the son of William Cox and Elizabeth Thomas. He was born in South Carolina in 1799, and died 27 July 1822.

1820

The federal census notes Jacob P\* living in Montgomery County, Ohio, in Randolph Township, living next to Adam Rodabaugh and his wife (and Jacob P\*'s daughter) Anna Catherine P\*. Jacob and Margaret P\* are listed in the wrong age bracket (26-45). They have living with them 1 boy under 10 and 2 girls under 10. These numbers do not correspond well with Jacob and Margaret P\*'s family, so the entry may be in error. It has the same marks as Adam's record which is next to it, and so it could have been mistakenly duplicated.

1820

On 24 April 1820 Jacob P\* receives the final deed for land at the very south edge of Patterson Township, Darke County (R4E, T6, S33, W half of SW quarter, 80 acres). There is no evidence that Jacob ever lived on this land, though his Wayne Township land could have been part of a contiguous piece. In the 1870s and 1880s this land and adjoining pieces in the same section were in the possession of the children of Jonathan B. P\*

1821	Jacob and Margaret P*'s daughter Elizabeth P* (Betsy) marries Adam "Sloonecker" (Slonecker) on 26 April in Montgomery County. Adam Slonacker's death date is not known.
1822	Jacob P* appears as the purchaser of a razor, shovel, quilt, shawl and an axe in the list of goods sold from the estate of (Jacob P*'s son-in-law) John Cox of Randolph Township, Montgomery County [10]. Some or all of these, however, may be Jacob Asbury P* citations.
1823	Jacob P*'s name appears as plaintiff in a case where he is trying (unsuccessfully) to remove William Cox as the guardian of his (Jacob P*'s) grandson Jacob Cox [12].
1825	Jacob and Margaret P*'s son Jacob Asbury P* marries Susanna Miller in Montgomery County on 6 September. There is a record of a Jacob P* taking a land patent in Clay Township of Montgomery County in 1827 who may be Jacob Asbury P*. A Jacob P* is on the 1830 census in the same Township. In 1840 Jacob Asbury P* is living in Perry Township of Montgomery County. In 1850 and 1860 he is in Neave Township of Darke County. Susanna Miller's stone in West Branch Cemetery, Neave Township, says that she died on 24 April 1859 at the age of 55. Jacob Asbury P* may have married again on 10 November 1861 to Christina Troup.
1827	Jacob and Margaret P*'s daughter Margaret P* marries Jacob "Metzkar" (Metzgar) in Montgomery County on 27 December. <sup>10</sup> Jacob Metzgar probably died in or before 1840, since there is a 26 December 1840 record appointing Jonathan B. P* the guardian of the deceased Jacob Metzgar's children.
1828	Jacob and Margaret P*'s son Henry P* marries Elizabeth Miller in Montgomery County on 25 September. <sup>11</sup> Elizabeth Miller was the sister of the Susanna Miller who had married Henry P*'s brother Jacob Asbury P* three years earlier.

Elizabeth Miller died on 11 February 1863, according to a Yoder Cemetery tombstone, aged 52 years, 5 months, 1 day.

1828

This would be a reasonable date for Jacob and Margaret P\*'s move from Montgomery to Darke County. Apparently there is an Ohio Land Record for Jacob P\* purchasing his Darke County land for cash in 1828, but I have not seen it.[24]

1830

Jacob P\* is on the federal census in Darke County, Wayne Township. In addition to Jacob and Margaret P\* there is a boy 15-19, 2 boys 20-29, a girl under 5, and a woman 20-29. The youngest boy would be Jonathan B. P\*. The older boys might be John D. P\* (age 21, still unmarried) and Henry P\* (age 24). The woman might be Henry P\*'s wife Elizabeth (age 20), and the younger girl her daughter Susanna P\*.

1834

Jacob and Margaret P\*'s son John D. P\* married Sarah "Sally" Pittzenberger, the daughter of his uncle Peter P\*, on 17 October 1834, in Darke County, Ohio. She died 27 June 1877, age 65 years, 20 days, according to her tombsone in Yoder Cemetery, Darke County.

1837

On July 31 Jacob P\*, living in Darke County, makes out his will [57]. He gives to his three sons Henry P\*, John D. P\*. and Jonathan B. P\*. 12 the 240 acres of Wayne Township land in Darke County. The rest of his goods, plus \$300 to be added by the three inheriting the land, were divided between his six other children. (When the probate was finished, the six children receiving money instead of land ended up with \$50.00 each.) Five children, Jacob P\*, Elizabeth P\* Slonaker, Anna Catherine P\* Rodabaugh (called "Katherine"), Phebe P\* Fetters and Margaret P\* Metzgar, received a share. The share of his (deceased and unmentioned) daughter Barbara P\* was given to her son Jacob Cox. The maintenance of his wife Margaret is entrusted to the three who inherited the land. Witnesses to the will were Elijah Ward and Daniel R. Davis.

1839

Jacob and Margaret's son Jonathan B. P\* marries Mary "Pittsenberger" in Darke County on 21 November. Mary P\* is the daughter of Jacob P\*'s brother Peter P\*. Mary P\*'s tombstone in Yoder Cemetery, Darke County, says that she died on 22 January 1859 at the age of 37 years, 3 months and 29 days.

1840

Jacob P\* in federal census. Living with him and his wife is 1 male 20-29, 2 males 30-39, one female under 5, and another 20-29. The man and woman 20-29 could be the Jonathan B. P\* who had just married. The girl could be Delilah Fetter, one

of the daughters of Phebe P\*, whose husband probably died in the spring of the year (see under 1817). I don't know who the older men (30-39) are.

Jacob's tombstone in Yoder cemetery indicates that he died on 9 July of this year, age 73 years, 5 months and 9 days. In December his wife Margaret registers a document with the court of common pleas of Darke County stating that she relinquishes her right to adminster Jacob P\*'s estate to Henry P\*.

1848 The Margaret Booher/Bucher/Butcher P\* tombstone in Yoder cemetery indicates that she died on 25 March, age 79.

### **Appendix A: Butcher Connections**

The maiden name of Margaret Booher/Bucher/Butcher, the wife of Abraham's son Jacob P\*, is known only through the reference in Morton [45]. I have spent some time trying to identify her family. Unfortunately there is no known Butcher family in the immediate vicinity of Abraham P\*'s land in Shenandoah County. We are left with trying to make connections to Butcher families who lived in the vicinity of Jacob and Margaret P\*.

If Butcher could be read as a variant of Booher (the German Bucher), then one possibility is that her parents were Peter and Catherine Booher of Fayette County, Pennsylvania. This is based on the fact that Jacob and Margaret P\* were in Bullskin Township, Fayette County, Pennsylvania, for a period in the early 1800s. In neighboring Saltlick Township were the Peter Boohers. The father Peter Booher Sr and the son Peter Booher Jr took original patents on tracts of land in 1785 (Peter Sr, "Mill Seat", 1785 Warrant) and 1786 (Peter Jr, "Booherville", patentee on 1784 warrant to Richard Brown). From Peter Sr's 1807 will [1] we learn that his children were Peter, George, Jacob, Henry, John, Catharina, Barbara, Elizabeth, Apollona, Margareth and Rosina. They seem to have been born in the 1760-90 period, so if the child Margareth was one of the earlier daughters, she could have been born circa 1770, about right for a 1792 marriage to Jacob P\*. There is no evidence, however, that this family of Boohers were in Shenandoah County at any point. And no other mention of P\*s in Fayette County has been found, in land, tax, church, or other records. Peter Booher Jr left Fayette County in the 1810s [20] for the west, but the brother George was still in Fayette County in 1820.

Another possibility is that Margaret was part a Bucher family that may have been in Frederick County, Virginia, in the 1790s. They were centered in Stephen's City, about 25 miles north of Abraham's land [6]. Data on this family is scanty at this point. The oldest known figure is a Jacob Bucher who died about 1800 [4]. There is no known Margaret connected with this family.

By far the most likely connection to neighboring Butcher families, however, is to a family of Butchers in southern Rockingham County, Virginia, that moved to Pendleton County, West Virginia. The outline of this family has only recently been put together [5]. This family, named "Metzger" in Germany, did a meaning-translation of the name to "Butcher" in the late 1700s. George Valentine Metzger (call him Valentine) came from Nieder-Linxweiler, Germany. He was the son of Johann Philip Metzger. George Valentine married Maria Elisabetha Kiepert, daughter of Johann Wilhelm Kiepert. In 1749 Valentine Metzger and his wife came to the American colonies, settling initially in Frederick County, Maryland. Valentine and Maria were the parents of several children, among whom were the sons Nicholas Butcher, Balthasar/Paulser Butcher, George Valentine Butcher Jr, and Jacob Butcher. George Valentine and his family moved about 1754 to the region around Bridgewater and Elkton in the southern part of Rockingham County, Virginia. By 1769 he was on the move again, this time across the mountains to South Mill Creek in Pendleton County. Valentine died about 1772. His children appear to have moved around a fair bit in the next 20 years, but the son Nicholas Butcher was back in Pendleton County by 1790. Nicholas married a Susanna. Jeff Carr and David Armstrong, who have researched this family, initially believed that Margaret P\* was the daughter of Nicholas and Susanna Butcher. Later correspondence with Jeff Carr points to a strong possibility

that Margaret was a late daughter of George Valentine Metzger and Maria Elisabetha Kiepert, and may have grown up the family of the son Nicholas Butcher after the parents died. They cite records saying that Jacob and Margaret P\* sold their Pendleton County land in 1797 and moved west with several other local families. In support of this connection to Nicholas Butcher is the fact that Jacob and Margaret's daughter Margaret (see under 1803 in the chronology) married a Metzger.

If this last connection proves to be the right one for Margaret Butcher, then we could postulate the following scenario: Jacob P\* marries Margaret Butcher of Pendleton County in 1792, meeting her through some unknown connections, perhaps because Jacob and Abraham had been working in Pendleton County. In 1794 Jacob and Abraham P\* decide to sell the Shenandoah County land they had inherited, with a view to purchasing land in Pendleton County. It may the one-week trip taken by examiners to see Margaret (see under 1794 in the chronology above) was to her home (or her parents) in Pendleton County. The sale of the land precipitates the final move of Jacob and Abraham to Pendleton County. They purchase land on Buckthorn Creek, about 15 miles south of Nicholas Butcher. Jacob leaves after a few years, Abraham stays behind in Pendleton County, where his descendants remain to this day.

Authors of works are indexed as persons. Generally the introductory words of titles ("A" or "The") have not been retained for index placement.

Because of variances in the spelling of  $P^*$  cognates, every  $P^*$  who is listed under a specific spelling in the work is also indexed under  $P^*$ .
